## If An Accident Happens

### • Do Not Leave The Scene

Failure to stop and remain at the scene of an accident can result in serious criminal consequences.

### • Call 911 To Get Help For Anyone Who Is Injured

Check yourself and other occupants of your vehicle for injuries before calling 911 to report the crash. If you or a passenger have been injured, remain in the car until help arrives provided it is safe to do so. Moving around can make some injuries worse, so wait for emergency personnel to assist you.

### • Gather The Information

### • Document the Accident Scene With Pictures

Take pictures of all vehicles involved in the accident before the vehicles are moved (if safe). Take pictures of damage up close and far away to document the extent of damage. Document skid marks, intersections, weather conditions and obstruction of views.

### • Be Careful What You Say

Admitting fault puts you at risk to not receive compensation for your injuries and damage to your vehicle that you may have otherwise been entitled to. Therefore, it is important that when you speak to the police, the other parties involved or the insurance companies that you do not admit fault.


